

WHEAT LAND COMMUNITIES' FAIR ~ CAMPGROUND RULES
2010 Historic Ritzville Days Western Art Show

1. Advance registration with Fair Secretary, PO Box 14, Ritzville, WA 99169 is recommended. (Any questions regarding the Historic Ritzville Days Western Art Show Executive Committee or registered participants (artists, artisans, authors, entertainers, cowboy poets) may contact (509) 659-1020 or ritzvilleartshow@gmail.com.)
2. Camping and RV spots are open to Western Art Show registered participants and non-participants.
3. Campground fees are \$15.00 per night with hook-up, \$10.00 per night without for registered participants ONLY. Non-registered participants will pay \$25.00 per night with hook-up, \$15.00 per night without. No sanitary hookups for camper/trailers will be provided.
4. Campground permits must be displayed in the window of camper or RV facing the fire lane or be attached to tent.
5. Lanes between parked campers/trailers must remain open at all times for emergency access and fire protection.
6. An adult must accompany all minors staying overnight. Any camper/trailer without adult supervision may be removed from the grounds.
7. No abusive drugs or alcohol will be allowed on the grounds at any time.
8. Pets must be on a leash. Any pet causing disturbance may be removed from grounds.
9. Turn lights off and keep campgrounds quiet after 11:00 p.m.
10. Wheat Land Communities' Fair, the Historic Ritzville Days Western Art Show or the Ritzville Downtown Development Association will not be responsible in case of fire, theft, accident or loss of any kind. It is your responsibility to so advise all persons sharing your camping facility.
11. Each site has a maximum of 15 amp draw. NO air conditioners to be run off of fairground power. Use of self-contained or on-board generators not permitted after 11:00 p.m.
12. The above stated rules are for your convenience and protection as well as to provide emergency information and location for the fair board personnel. Completion of the registration form and payment thereof constitutes acceptance of the foregoing rules by the adult in charge and all members using your assigned camp area.
